## **APPLICATION REQUIREMENTS**

- 1. Applications must be typed.
- 2. Two letters of recommendation are required; <u>one</u> must come from the school, and <u>one</u> from an event/organization/employer (<u>not school related</u>) that the student is involved in.
- 3. Attach your high school transcript.
- 4. An interview may be conducted with the Scholarship Committee.
- 5. Submit the completed applications (Fremont Federal Credit Union and Northwest Chapter of Credit Unions) and all other required letters to:
